Information disclosed to credit reporting agencies (including default information) will be held by each agency on its system accessed by the customers of the credit reporting database and used to provide its credit reporting services (including the maintenance of credit information files and supplying the information to other customers of the relevant credit reporting agency). Under the Privacy Act 2020, individuals have rights of access to, and correction of, their personal information. OrbitProtect may also process information in accordance with its privacy policy located on OrbitProtect's website.
